Class E Driver License and Identification Card Required

Federal law requires that you present specific documents to comply with the REAL ID ACT & FLORIDA STATUTES 322.08. If you have already done so in Florida, your license or ID will have a star in the upper right corner and unless you are making a change on your license or ID (e.g., name, residential address) ... no documents will be required.

ALL DOCUMENTS MUST BE ORIGINALS OR CERTIFIED COPIES. NO PHOTOCOPIES ACCEPTED.

1. Primary Identification: [Bring one](#)

- Certified U.S. birth certificate
- Valid or expired U.S. passport / card
- Certificate of Naturalization / Citizenship
- Consular Report of Birth Abroad
- Alien registration receipt card (Green card, 551)

Have you legally changed your name from your primary identification due to marriage or a court order?

- Original or certified copy of all marriage certificates or court orders that link your name from your primary identification to the name on driver license or ID card

2. Acceptable Proof of Social Security Number [Bring one](#)

- Social Security Card
- W-2 form (*not handwritten*)
- Paycheck / stub
- Any 1099 form (*not handwritten*)

3. Acceptable Proof of Residential Address for Class E and Identification Cards [Bring two](#) (Proof of address must be printed prior to visiting our offices)

- Deed, mortgage, monthly mortgage statement, residential rental/lease agreement, property tax bill
- Utilities bills – (Ex. water, gas, electricity, cell phone, cable) (must be dated within the last 60 days)
- Valid Florida Vehicle/Vessel Registration or Title
- Medical or Health card and/or Medical bill (must be dated within the last 60 days)
- Employer Documentation (latest W-2 form or 1099 form) or paycheck stub (must be dated within the last 60 days)
- Homeowner's and/or Automobile insurance policy or bill (last bill still in effect)
- Florida Voter Registration Card
- Automobile Payment Booklet (must be dated within the last 60 days)
- Mail/Documents issued by Federal, State, County or City government agencies (including city and county agencies) (must be dated within the last 60 days)

4. Non-immigrants

- Must provide original immigration documents with every issuance

Veteran Designation

Honorably Discharged U.S. Military Veterans may have the Veteran designation placed on his/her license.

- Provide DD-214 or other approved discharge documentation at time of issuance.
